that Defective Detective Jason Price was simply a LIAR!!!

After Judy's testimony, Randy Kelton and Dave Mack prevailed upon me as to the fact that I was not well and it was showing in my performance, wherefore they were strongly suggesting that I should have the court appointed attorney, Sten Langsjoen, take over, whereupon Sten insisted on an allowance of time to bring himself up on my defenses, so judge Dwight Phifer declared he wanted me to obtain a doctor's check up in order to verify the state of my physical health, and proceedings that morning were adjourned until Thursday morning 9:00 am. I traveled to Tyler Texas and was able to obtain a properly detailed check up from

I traveled to Tyler Texas and was able to obtain a properly detailed check up from Dr. DeWet MD., whose report plainly stated that I was an emergency case urgently requiring medical care!!!

Thursday, March 29 judge Dwight Phifer gave the jury the day off expecting me to bring attorney Sten Langsjoen up to speed, in order for the case to continue with the Jury on Friday morning, so I made a valiant effort to prepare for the next day.

Friday, March 30 after being up all night, unable to sleep due to my lungs filling up with fluid, and rendering me utterly exhausted from trying to keep breathing with a greatly reduced lung capacity, by phone I informed Dave Mack and Caleb Eaton who were in a nearby motel room, that I would have to go to the hospital. Attorney Sten Langsjoen witnessed the massive swelling in my legs and my shortness of breath just before Caleb Eaton took me to Trinity Mother Francis Hospital in Jacksonville where I was immediately admitted at the Emergency care area.
