1. CIRCUMSTANCES NECESSITATING COLLECTION OF INFORMATION

IRS sections 6011 and 6012 of the Internal Revenue Code require individuals to prepare and file income tax returns annually. Form 1040 is used by individuals to report their income **subject to tax and compute their correct tax liability.**
